

## Terms of Use

Last updated: August 20, 2024

These Affiliate Program Terms supplement and form part of our Standard Terms of Use

As used herein, "ASIGPT" refers to a specific company of ASIGPT AI LIMITED (hereinafter referred to as "ASIGPT"), depending on the user's residence, place of incorporation and/or nationality.

3. Please consider the following important restrictions before deciding whether to participate in the Affiliate Program.

By entering the Affiliate Program when you create an account on the Site to use the Services (an "Account"), you acknowledge that you have read, understood and fully agree to these Affiliate Program Terms, as updated and revised from time to time. If you do not wish to be bound by these Affiliate Program Terms, as updated and revised from time to time, you must:

- (1) never enter, generate or send a Referral Code (as defined below)
- (2) cease your participation in the Affiliate Program by opening a support ticket and completing the process required by ASIGPT. Only users with current accounts may participate in the Affiliate Program.

## 1. Description

- (L3) ASIGPT may reclaim, deactivate, invalidate or terminate your Referral Code at any time in its sole discretion.

## 3. Restrictions

3.6 Sharing referral links using fake accounts. You agree that you will not create or use any fake web pages, social media profiles, conduct fraudulent activities or any other prohibited illegal activities.

#### 4. Responsibilities

8.5 The information on the Statistics page is updated in real time.

## 9. Information
